1. SCOPE

The purpose of this bid request is to get all street lighting back to working condition on Rush Road. This will consist of, replacing or repairing electrical wiring and electrical components that were damaged during a theft and repairing current nonfunctional street lights (See Attached Exhibit A).

Work limits are, Rush Road between mile post 3.164 (Bishop Road) and mile post 3.796 (Maurin Road) and two street lights on Maurin Road. All materials and performance shall meet the requirements per the 2016 Washington State Standard Specifications and all applicable current electrical codes adopted by Washington State.
