

# LEWIS COUNTY SOLID WASTE UTILITY - TRANSFER STATION GRADE AND GRAVEL PROJECT REQUEST FOR SEALED BID

## 1. SCOPE

The purpose of this request for sealed bid is to provide grade improvement and gravel at Lewis County's Central Transfer Station yard waste receiving area, located at 1411 S Tower, Centralia, WA.

- Blade and grade existing yard waste debris area of Central Transfer Station (approximately 16,000 square foot).
- Deliver and evenly apply approximately 2-inch covering of gravel. Gravel spec = 1<sup>1</sup>/<sub>4</sub>-inch
- 1<sup>1</sup>/<sub>4</sub>-inch crushed top course. (Previous project used approximately 60 tons of 5/8-inch gravel)

The successful bidder shall provide all equipment and materials necessary to complete service, which may include backup equipment/vehicles. The successful bidder will be restricted to performing work on Thursday or Friday to minimize impacts to facility operations. The successful bidder should be prepared to submit proof of commercial insurance and any required licenses or certificates.

## 3. SPECIFICATIONS

The work shall be in accordance with the Occupational Health and Safety Administration and, Washington State Department of Labor and Industries. The work shall be performed on Thursday or Friday minimizing impacts to the facility operations.
