## **Delivery and Marking of Sealed Bid Proposals**

Sealed proposals must be delivered to the Clerk of the Board of Lewis County Commissioners (351 N.W. North Street, Room 210, CMS-01, Chehalis, Washington 98532) by or before 12:15 P.M. on the date specified for opening, and in an envelope clearly marked: "SEALED BID FOR LEWIS COUNTY 2021 SNOW SAND PROPOSAL TO BE OPENED ON OR AFTER 12:15 P.M. ON AUGUST 12, 2021."

## 1. SCOPE

This Bid request is to contract the production of approximately 9,000 ton of snow sand, as specified below, for purchase by Lewis County. The Contractor shall allow the Contracting Agency to sample the snow sand stockpiled at their pit site for approval. Upon production of each 2,000 ton of Contracted quantity for each bid item, the County's representative will begin testing and verification that the product meets the Specifications for the product to be accepted.

The Contractor hereby grants the Contracting Agency and/or its authorized contractors the right of ingress and egress and to enter upon the pit site at times listed as hours of work in the progress schedule until the completion of this contract.

No source has been provided for any materials necessary for the completion of this contract. The Contractor shall be responsible for obtaining all necessary permits in regard to this Contract.

#### 3. SPECIFICATIONS

All material shall meet the requirements listed in the Washington State Department of Transportation 2021 Standard Specification for Road, Bridge, and Municipal Construction. The work on this contract is to be performed upon lands whose ownership obligates the Contractor to collect State sales tax from the Contracting Agency. The provisions of Section 1-07.2(2) apply.

As per RCW 36.32.256, haul distance for County forces shall be factored into the submitted bids to determine which vendor is truly the lowest price to the County. The County reserves the right to reject any or all bids, waive informalities and to contract as the best interests of the County may appear. In determining the lowest responsive bidder, consideration will be given to such factors as prices quoted, County hauling cost, and quality of the product. Haul distance shall be determined from the Contractor's pit address to the stockpile location using Google Map.
