3 **INTRODUCTION**

4 (Lewis County)

5 The following Special Provisions are made a part of this contract and supersede any conflicting
6 provisions of the 2022 Standard Specifications for Road, Bridge, and Municipal Construction.

7
8 The said Standard Specifications thereto, the WSDOT Standard Plans, and WSDOT Construction
9 Manual, together with the Special Provisions and the attached plans hereinafter contained, covering
10 all work specified under this contract are incorporated and hereby made a part of this contract. The
11 Special Provisions hereinafter contained shall supersede any conflicting provisions of the Standard
12 Specifications thereto, the WSDOT Standard Plans, and WSDOT Construction Manual.

13
14 Several types of Special Provisions are included in this contract; General, Region, Bridges and
15 Structures, and Project Specific. Special Provisions types are differentiated as follows:

23 **General Special Provisions** are similar to Standard Specifications in that they typically apply to
24 many projects, usually in more than one Region. Usually, the only difference from one project to
25 another is the inclusion of variable project data, inserted as a “fill-in”.

26
27 **Project Specific Special Provisions** normally appear only in the contract for which they were
28 developed.

29
30 The following paragraph pertaining to the Standard Specifications shall obtain and be made a part
31 of this contract:

33 Wherever the word “State” or “Contracting Agency” is used it shall mean Lewis County; that
34 wherever the words “Secretary (Secretary of Transportation)” are used they shall mean
35 Lewis County Engineer; that wherever the words “State Treasurer” are used they shall
36 mean Lewis County Treasurer; that wherever the words “State Auditor” are used they shall
37 mean Lewis County Auditor; that wherever the words “Motor Vehicle Fund” are used they
38 shall mean Lewis County Road Fund.

31 Special Provisions;

33 required in Section 1-02.6, or if the documentation that is submitted fails to
34 demonstrate that a Good Faith Effort to meet the Condition of Award was made;

14 **1. Delinquent State Taxes**

16 A Criterion: The Bidder shall not owe delinquent taxes to the Washington State
17 Department of Revenue without a payment plan approved by the Department of

21 statement (on a form to be provided by the Contracting Agency) that the Bidder
22 does not owe delinquent taxes to the Washington State Department of Revenue, or
23 if delinquent taxes are owed to the Washington State Department of Revenue, the
24 Bidder must submit a written payment plan approved by the Department of
25 Revenue, to the Contracting Agency by the deadline listed below.

29 A Criterion: The Bidder shall not currently be debarred or suspended by the Federal
30 government.
31

32 B. Documentation: The Bidder shall not be listed as having an “active exclusion” on the
33 U.S. government’s “System for Award Management” database (www.sam.gov).
34

35 **3. Subcontractor Responsibility**

36
37 A Criterion: The Bidder’s standard subcontract form shall include the subcontractor
38 responsibility language required by RCW 39.06.020, and the Bidder shall have an
39 established procedure which it utilizes to validate the responsibility of each of its
40 subcontractors. The Bidder’s subcontract form shall also include a requirement that
41 each of its subcontractors shall have and document a similar procedure to
42 determine whether the sub-tier subcontractors with whom it contracts are also
43 “responsible” subcontractors as defined by RCW 39.06.020.
44

45 B. Documentation: The Bidder, if and when required as detailed below, shall submit a
46 copy of its standard subcontract form for review by the Contracting Agency, and a
47 written description of its procedure for validating the responsibility of subcontractors
48 with which it contracts.
49

50 **4. Claims Against Retainage and Bonds**

51
52 A Criterion: The Bidder shall not have a record of excessive claims filed against the
53 retainage or payment bonds for public works projects in the three years prior to the
54 bid submittal date, that demonstrate a lack of effective management by the Bidder of

1 making timely and appropriate payments to its subcontractors, suppliers, and
2 workers, unless there are extenuating circumstances and such circumstances are
3 deemed acceptable to the Contracting Agency.
4

5 B. Documentation: The Bidder, if and when required as detailed below, shall submit a
6 list of the public works projects completed in the three years prior to the bid
7 submittal date that have had claims against retainage and bonds and include for
8 each project the following information:

- 9
- 10 • Name of project
- 11 • The owner and contact information for the owner;
- 12 • A list of claims filed against the retainage and/or payment bond for any of the
- 13 projects listed;
- 14 • A written explanation of the circumstances surrounding each claim and the
- 15 ultimate resolution of the claim.

16
17 **5. Public Bidding Crime**

18
19 A Criterion: The Bidder and/or its owners shall not have been convicted of a crime
20 involving bidding on a public works contract in the five years prior to the bid
21 submittal date.

22
23 B. Documentation: The Bidder, if and when required as detailed below, shall sign a
24 statement (on a form to be provided by the Contracting Agency) that the Bidder
25 and/or its owners have not been convicted of a crime involving bidding on a public
26 works contract.

27
28 **6. Termination for Cause / Termination for Default**

29
30 A Criterion: The Bidder shall not have had any public works contract terminated for
31 cause or terminated for default by a government agency in the five years prior to the
32 bid submittal date, unless there are extenuating circumstances and such
33 circumstances are deemed acceptable to the Contracting Agency.

34
35 B. Documentation: The Bidder, if and when required as detailed below, shall sign a
36 statement (on a form to be provided by the Contracting Agency) that the Bidder has
37 not had any public works contract terminated for cause or terminated for default by a
38 government agency in the five years prior to the bid submittal date; or if Bidder was
39 terminated, describe the circumstances. .
40

41 **7. Lawsuits**

42
43 A Criterion: The Bidder shall not have lawsuits with judgments entered against the
44 Bidder in the five years prior to the bid submittal date that demonstrate a pattern of
45 failing to meet the terms of contracts, unless there are extenuating circumstances
46 and such circumstances are deemed acceptable to the Contracting Agency

47
48 B. Documentation: The Bidder, if and when required as detailed below, shall sign a
49 statement (on a form to be provided by the Contracting Agency) that the Bidder has
50 not had any lawsuits with judgments entered against the Bidder in the five years
51 prior to the bid submittal date that demonstrate a pattern of failing to meet the terms
52 of contracts, or shall submit a list of all lawsuits with judgments entered against the
53 Bidder in the five years prior to the bid submittal date, along with a written

1 explanation of the circumstances surrounding each such lawsuit. The Contracting
2 Agency shall evaluate these explanations to determine whether the lawsuits
3 demonstrate a pattern of failing to meet of terms of construction related contracts
4

5 As evidence that the Bidder meets the Supplemental Criteria stated above, the apparent low
6 Bidder must submit to the Contracting Agency by 12:00 P.M. (noon) of the second business
7 day following the bid submittal deadline, a written statement verifying that the Bidder meets
8 the supplemental criteria together with supporting documentation (sufficient in the sole
9 judgment of the Contracting Agency) demonstrating compliance with the Supplemental
10 Criteria. The Contracting Agency reserves the right to request further documentation as
11 needed from the low Bidder and documentation from other Bidders as well to assess Bidder
12 responsibility and compliance with all bidder responsibility criteria. The Contracting Agency
13 also reserves the right to obtain information from third-parties and independent sources of
14 information concerning a Bidder's compliance with the mandatory and supplemental criteria,
15 and to use that information in their evaluation. The Contracting Agency may consider
16 mitigating factors in determining whether the Bidder complies with the requirements of the
17 supplemental criteria.

18
19 The basis for evaluation of Bidder compliance with these mandatory and supplemental
20 criteria shall include any documents or facts obtained by Contracting Agency (whether from
21 the Bidder or third parties) including but not limited to: (i) financial, historical, or operational
22 data from the Bidder; (ii) information obtained directly by the Contracting Agency from others
23 for whom the Bidder has worked, or other public agencies or private enterprises; and (iii) any
24 additional information obtained by the Contracting Agency which is believed to be relevant to
25 the matter.

26
27 If the Contracting Agency determines the Bidder does not meet the bidder responsibility
28 criteria above and is therefore not a responsible Bidder, the Contracting Agency shall notify
29 the Bidder in writing, with the reasons for its determination. If the Bidder disagrees with this
30 determination, it may appeal the determination within two (2) business days of the
31 Contracting Agency's determination by presenting its appeal and any additional information to
32 the Contracting Agency. The Contracting Agency will consider the appeal and any additional
33 information before issuing its final determination. If the final determination affirms that the
34 Bidder is not responsible, the Contracting Agency will not execute a contract with any other
35 Bidder until at least two business days after the Bidder determined to be not responsible has
36 received the Contracting Agency's final determination.

21 for bids until a more competitive situation exists.

23 The County reserves the right to reject any or all bids, waive informalities and to contract as
24 the best interests of the County may appear. As per RCW 36.32.256 the County also
25 reserves the right to select the lowest bidder for each of the different bid items whether it be
26 the same bidder or not. In determining the lowest responsive bidder, consideration will be
27 given to prices quoted for each bid item outlined in the proposal (including sales tax at pit
28 location), the haul distances from Contractors' pits to stockpile sites with County trucking
29 rates.

30 **1-03.7 Judicial Review**

3 Agency may deem necessary.

5 If the Contractor fails to comply with a written order to remedy what the Engineer determines to
6 be an emergency situation, the Engineer may have the defective and unauthorized work
7 corrected immediately, have the rejected work removed and replaced, or have work the
8 Contractor refuses to perform completed by using Contracting Agency or other forces. An
9 emergency situation is any situation when, in the opinion of the Engineer, a delay in its remedy
10 could be potentially unsafe, or might cause serious risk of loss or damage to the public.
11

12 Direct or indirect costs incurred by the Contracting Agency attributable to correcting and
13 remedying defective or unauthorized work, or work the Contractor failed or refused to perform,
14 shall be paid by the Contractor. Payment will be deducted by the Engineer from monies due, or
15 to become due, the Contractor. Such direct and indirect costs shall include in particular, but
16 without limitation, compensation for additional professional services required, and costs for repair
17 and replacement of work of others destroyed or damaged by correction, removal, or replacement
18 of the Contractor's unauthorized work.
19

20 No adjustment in contract time or compensation will be allowed because of the delay in the
21 performance of the work attributable to the exercise of the Contracting Agency's rights provided
22 by this Section.
23

24 The rights exercised under the provisions of this section shall not diminish the Contracting
25 Agency's right to pursue any other avenue for additional remedy or damages with respect to the
26 Contractor's failure to perform the work as required.
27
